

Title: “Kansai Paint Jom Beraya Sakan 2023 Campaign” Terms and Conditions

1.0 Eligibility

- 1.1 The “Kansai Paint Jom Beraya Sakan Campaign” (“the Campaign”) is open to all Malaysian residents aged 18 and above (as of January 1st, 2023).
- 1.2 Submission from participants under the age of 18 (as of January 1st, 2023) are assumed to have parental consent prior to participation in the Campaign.

The Organizer will within 14 working days verify the validity of the entry and contact the participant post-verification.

After successful verification the participant is required to redeem the KFC Voucher at a designated dealer.
